AUDIT FINDINGS

Narrative:

Dismas Charities, Inc. contracted with DX Consultants, LLC, 914 Gasparilla Dr., St. Petersburg, FL 33702 for PREA Auditing Services of the Dismas Charities-Jackson. The purpose of the audit was to determine the Dismas Charities-Jackson's level of compliance with the standards of the Prison Rape Elimination Act of 2003. The PREA audit of the Dismas Charities-Jackson (Dismas Charities-Jackson) was conducted on June 28-29, 2021 by Trish Brockman-Bernhards, US DOJ Certified PREA Auditor. The facility is a residential reentry center located at 233 East Rankin Street, Jackson, Mississippi 39201. This was the facility's first PREA audit.

Pre-Onsite Audit Phase

The audit process began on May 18, 2021, when an informational email was sent to the Dismas Charities, Inc. PREA Coordinator. The email contained information regarding who the assigned auditor was, the date the pre-audit notices were to be posted, when the Pre-Audit Questionnaire was due and the actual date of the onsite audit. The email also addressed the posting of the attached bilingual PREA Audit Notices containing the address residents could write to and confidentially contact the auditor prior to the auditor's arrival at the facility. The auditor received no correspondence from any residents prior to the onsite portion of the audit. While onsite, there were no special requests from the resident population to speak with the auditor either.

Facility staff were instructed in the informational email as to what areas of the facility the audit notices should be posted to and to take photos of the notices when posted, dated if possible and identify the location of where the notices were posted. The auditor received correspondence in the form of email and photos that the notices were posted were loaded on the Online Audit System on May 19, 2021. The bilingual audit notices were verified during the onsite tour in various locations throughout the facility including the main lobby, cafeteria and staff copy area.

The auditor received notification that the PAQ was updated and submitted to the Online Audit System (OAS) on June 2, 2021. The pre-audit review of the updated documentation commenced. The auditor completed a documentation review using the Pre-Audit Questionnaire. The Dismas Charities, Inc. PREA Coordinator and Dismas Charities-Jackson PREA Compliance Manager uploaded information, that included policies, procedures, training records, internet research, and supporting documentation for all forty-one (41) standards. The documentation uploaded to the OAS for each standard contained the supporting documentation in-regards to the Pre-Audit Questionnaire; however, the information did not sufficiently address each standard and minimal additional information had to be requested. Additional supporting documentation was provided to the auditor during the on-site and after the facility's on-site visit. The supporting documentation was uploaded to the OAS under the supplemental files.

A conference call was scheduled for June 23, 2021, with the PREA Compliance Manager (PCM) to review the schedule for the on-site visit, discuss the auditor's results of the Pre-Audit Questionnaire and supporting documentation provided on the OAS and review information to be sent to the auditor prior to the on-site visit to the facility. The information requested was to include the following:

The PCM sent the documentation (staff roster, staff schedule for random and specialized staff etc.) to the auditor prior to arrival at the facility. Also, additional supporting documents were provided during the on-site visit to address the deficiencies.

Research

During the pre-on-site audit phase, the auditor conducted internet searches on the facility and agency and reviewed the Dismas Charities, Inc. web page at www.dismas.com. The website includes the PREA zero-tolerance policy, investigative information, previous PREA audit reports, PREA reporting information and annual reports. The general public can access the PREA policy on the website.

Dismas Charities Jackson has been attempting to establish an MOU with the Mississippi Coalition Against Sexual Assault for emotional support services for resident victims of sexual abuse. The auditor was able to make telephone contact with a victim advocate from the Mississippi Coalition Against Sexual Assault. Details of the telephone interview are provided in the applicable sections of this report. Just Detention International and RAINN (the Rape, Abuse & Incest National Network) were contacted to determine if the agency had reported any complaints from the facility in the past twelve (12) months. Both organizations reported they did not have any contact from residents of Dismas Charities-Jackson.

Contact was also made with a Sexual Assault Nurse Examiner (SANE) with the Baptist Medical Center by telephone. The auditor and the SANE discussed the forensic services offered to resident victims of sexual abuse. During the call, the SANE was able to explain that community level of care is offered to all patients, even resident victims of sexual abuse. Details of the telephone interview are provided in the applicable section of this report.

Onsite Review

Dismas Charities-Jackson (Dismas Charities-Jackson) is located in Hinds County Mississippi. The address is 233 East Rankin Street, Jackson, Mississippi 39201.

The facility's design capacity is (Redacted) with an average daily population of (Redacted) (total residential and home confinement). The resident count on the first day of the audit was (Redacted).

The on-site audit was conducted on June 28-29, 2021. The auditor arrived at the Dismas Charities-Jackson the morning of June 28, 2021. An entrance briefing was conducted with the Regional Vice President, PREA Coordinator, Assistant Director and the Director. During the entrance briefing, the audit process was explained and a tentative schedule for a day and a half to include the facility tour, conducting

interviews with the staff and residents and reviewing the documentation. A brief discussion was held regarding current facility operations due to Covid-19 impacting the resident population. The discussion involved how interviews could be conducted safely.

A complete guided tour of the entire facility was conducted by the Regional Vice President, PREA Coordinator and Director. The tour included the administrative office area, resident dorm room (male and female), cafeteria and outside recreational area. The tour ended after approximately a half (.5) hour.

During the tour, the auditor was allowed unimpeded access to any area of the facility. While touring, the auditor was seeking to find blind spots, listening for opposite gender announcements, observing staff and resident interactions as well as searches conducted by staff and locating camera and security mirror placements. The auditor also reviewed the facility schematics. Dismas Charities-Jackson has (Redacted) cameras. Camera placement was internal and external included stationary and PTZ cameras. The cameras are monitored in the various offices and have an approximate (Redacted) recording capability.

Informal and formal conversations with employees and residents were conducted. Notifications of the PREA audit was posted in all locations throughout the facility as well as postings informing residents of the telephone numbers to call and report sexual abuse and sexual harassment and to call the victim advocate for emotional support services.

Staff Interviews

The PREA Auditor Handbook requires auditors to interview at least twelve (12) random sample of staff. The auditor conducted twelve (12) random sample of staff interviews which were all of the staff working during the onsite audit. The auditor interviewed a variety of staff from a diverse cross-section of work assignments, supervisors and line staff, males and females and staff of various races. There were three shifts. The hours for each shift were 0730-1600 hours, 1530-0000 hours and 2330-0800 hours. Hours for Administrative staff were 0800-1630 hours. The facility reported nineteen (19) staff positions at the facility with all (Redacted) staff positions being filled. Private interviews with staff were conducted in the Conference room while practicing social distancing. There were twenty-two (22) specialized interviews conducted with twelve (12) staff as some staff were interviewed for multiple categories. Specialized individuals were selected based upon their subject matter expertise in the various areas. The facility does not house youthful residents, therefore, interviews for line staff who supervise youthful residents and education and program staff who work with youthful residents were not conducted. The facility personnel were found to be cooperative and professional. Staff morale appeared to be very good and the observed staff/resident relationships were determined to be professional.

The facility reported in its PAQ that zero (0) volunteers and one (1) contractor had been trained in agency policies and procedures regarding sexual abuse and sexual harassment prevention, detection and response policies and procedures. Due to restrictions in place at the facility because of the coronavirus, outside volunteers not employed by the facility have not been allowed to enter the facility. An interview with the contractor was conducted in person at the facility. The interview confirmed they completed the Sexual Abuse and Harassment 101 training and their knowledge obtained about NCDPS zero tolerance and their duty to report sexual abuse and harassment. Training documentation confirmed the contractor completed the required training.

There is evidence of Dismas Charities-Jackson's Director attempting to obtain a Memorandum of Understanding with the Mississippi Coalition Against Sexual Assault to provide free confidential crisis intervention and emotional support services related to sexual abuse residents. Any resident seeking services can call the telephone number at no additional cost to the resident. The auditor contacted a representative from the Mississippi Coalition Against Sexual Assault and she explained the services the Mississippi Coalition Against Sexual Assault offers. She reported there were no calls made to the Mississippi Coalition Against Sexual Assault in the past twelve (12) months from Dismas Charities-Jackson. Baptist Medical Center provides the emergency services and the forensic medical examinations at no financial cost to the victim. In an interview with the SANE nurse, no Dismas Charities-Jackson residents had been provided forensic exams at the Baptist Medical Center.

All staff interviews were conducted with the guidance of the national PREA Resource Center, PREA Compliance Audit Instruments-Interview Guide. The Interview Preparation Sheet and employee rosters received when arriving onsite assisted the auditor with the selection process for the random and targeted staff. A detailed list and quantity of staff interviewed are noted below.

Resident Interviews

During the two (2) day on-site visit, there was a total of (Redacted) male residents in the facility while the auditor was onsite. There were no females assigned to the facility during the onsite portion of the audit. (Redacted) residents were on Home Confinement. The PREA Auditor Handbook requires auditors to interview at least ten (10) random sample of residents. The auditor conducted eighteen (18) random sample of resident interviews. The PCM provided the auditor with a resident list provided for the interview process. The random residents were selected from all three (3) dorm rooms. The interviewed residents were of various ages, nationalities and ethnic backgrounds.

The PREA Auditor handbook requires auditors to interview at least ten (10) targeted residents. There were no residents that met any of the targeted area categories, thus the reason for the extra random inmate interviews. There were two (2) targeted resident interviews conducted. The facility reported they did not have the following targeted resident categories housed at the facility during the onsite review. As a result, additional random resident interviews were conducted. These categories of residents were not interviewed:

- Residents who Reported Sexual Abuse
- Youthful Residents
- Residents who Disclosed Prior Sexual Victimization During Risk Screening
- LGBTI Residents
- Residents in Restrictive Housing for High Risk of Sexual Victimization
- Residents who were Blind, Deaf or LEP
- Residents with Cognitive Disability

There were zero (0) residents who met multiple identified categories from the required list of targeted resident interviews. Although the PREA Auditor Handbook requires a minimum of ten (10) targeted resident interviews, there were no residents among the population that met three categories. During staff interviews, questions were asked to ascertain if residents in these three categories were known among the population. Additional random residents were interviewed.

All resident interviews indicated they were well informed of their right to be free from sexual abuse and sexual harassment and how to report sexual abuse and sexual harassment using several ways of communication such as trusted staff, the Director, from the kiosk and the Mississippi Coalition Against Sexual Assault for crisis intervention and victim advocate services. Overall, the residents interviewed demonstrated an understanding of the PREA compliance program, the intake screening process, the prevention and protection process and reporting mechanisms Dismas Charities Jackson had in place. Residents interviewed further stated that staff members were responsive to their needs and reported that they felt safe at this facility.

All resident interviews were conducted with the guidance of the National PREA Resource Center, PREA Compliance Audit Instruments-Interview Guide. The Interview Preparation Sheet and resident rosters received when arriving onsite assisted the auditor with the selection process for the random and targeted residents. Private interviews were conducted in the Conference Room. A detailed list and quantity of residents interviewed are noted below.

File Review

Based upon the information provided on the PREA Audit Request for Information form completed by the Dismas Charities-Jackson staff, the auditor was able to determine the facility had zero (0) sexual abuse allegations and zero (0) sexual harassment allegations for the last twelve-month time period, as such there were no investigation files to review.

Employee personnel files were maintained in the Director's Office. The criminal background records check documentation was maintained in the employee personnel files. The auditor reviewed documentation from five (5) employee personnel files and one (1) contractor file. When selecting the files, the auditor considered reviewing employee files of newer employees who were recently hired as well as staff who had been employed with the facility and staff that were recently promoted to positions at the facility. Training files were reviewed on the same staff.

The auditor reviewed documentation from five (5) resident files. Documentation in the files included resident education participation acknowledgement forms as well, initial as completion of the facility Orientation Program that included additional information regarding PREA.

Close-Out

At the end of the onsite portion of the audit, an exit debriefing June 29, 2021 a summary of the findings was conducted with the Regional Vice President and Director. At the exit debriefing, the auditor gave an overview of the audit and commented on the on-site observations, interviews, and summarized the strengths and weaknesses after completing the Pre-Audit and On-Site Audit phases. Discussion regarding follow up on the hiring process, specific to PREA related questions being asked of applicants was also held and changes were already underway. There was a discussion that if further documentation was needed the auditor would work through the PREA Coordinator. The auditor thanked the Regional Vice President, Director and her staff for their hard work and dedication to the PREA process.

AUDIT FINDINGS

Facility Characteristics:

The auditor's description of the audited facility should include details about the facility type, demographics and size of the inmate or resident population, numbers and type of staff positions, configuration and layout of the facility, numbers of housing units, description of housing units including any special housing units, a description of programs and services, including food service and recreation. The auditor should describe how these details are relevant to PREA implementation and compliance.

Dismas Charities Jackson is operated by Dismas Charities, Inc.. The facility is located at 233 East Rankin Street, Jackson, Mississippi 39201. The facility is a residential reentry center that opened in 2020 with a rated capacity of 45 beds. The facility operates under a contract with the Bureau of Prisons (BOP)/US Probation Office and provides community-based services and programs to the residents assigned to the facility. The facility currently has (Redacted) staff full and part time positions. Prior to Covid, volunteers and interns may have also had contact with the residents. The facility is one single story structure with multiple dormitory style rooms. The Central Monitoring Office (CMO) contains camera monitoring equipment that allows video monitoring from internally and externally placed cameras strategically located throughout the facility. Staff are assigned to the CMO and are required to monitor the cameras. CMO staff are also responsible for monitoring the internal movement of the resident population, staff and any visitors throughout the facility as well as the resident population assigned to Home Confinement status.

The facility is required to minimally have one male and one female staff member onsite at all times. Staffing includes resident monitors, counselors, an employment specialist, cooks, an Assistant Director and the Director.

The age range of the resident population during the onsite portion of the audit was 18-67 years old. The facility does not house youthful residents. The design capacity is (Redacted). The resident onsite count on the first day of the audit was (Redacted). The facility staffing consists of security and non-security employees. Non-security staff include administrative staff, case management and the cooks. The PAQ indicated there were (Redacted) staff assigned to the facility. The daily operations are managed by resident monitors. There are three shifts at the facility. The shift times are 7:30am-4:00pm hours, 3:30pm-12:00am hours and 1130pm-8:00am hours.

The facility has a total of (Redacted) dorm rooms. Residents sleep in bunk beds in each area. The auditor observed PREA materials posted on the dorm units, and PREA posters throughout all areas of the facility. Residents have access to televisions, telephones, and chairs in their respective dayrooms. The female dormitory, (Redacted), sleeps (Redacted) residents. The female dorm has a solid door providing a level of privacy for the female residents. The windows of the dayroom area have frosted windows allowing an element of natural light but also provides a level of privacy for the female residents. The female dormitory has one bathroom area that is equipped with one shower with a privacy curtain and one bathroom stall with a locking solid door. Male residents are assigned to (Redacted) male dormitory rooms, (Redacted). Each shower and toilet/urinal area have barriers that allow residents the ability to shower, use the restrooms and change clothing without staff of the opposite gender being able to view them.

The facility has not made any substantial expansion or modification to the existing facility since it opened in July 2020. Documentation and interviews confirmed the practice that if any expansion or modifications to the existing facility would occur, consideration is to be given of the effect of any modifications, expansion, and/or updating of video monitoring system would have on the facility's ability to protect the residents and staff from sexual abuse/harassment. Medical care and mental health services are offered by practitioners employed by the facility. Forensic medical exams are completed at the Baptist Medical Center.

AUDIT FINDINGS**Summary of Audit Findings:**

The Auditor found that Dismas Charities, Inc./Dismas Charities Jackson have developed appropriate policies and procedures that aid in prevention, detection and response to sexual abuse and sexual harassment. The Auditor found the facility's staff are well trained and retained information provided through the agency's training efforts. The Auditor formally interviewed staff and determined staff understood their responsibilities in the agency's policies and procedures regarding the prevention, detection and response towards acts of sexual abuse and sexual harassment. Staff understand their roles as first responders to incidents of sexual abuse and sexual harassment. The Auditor determined the facility has been successful in developing a zero-tolerance culture towards all forms of sexual abuse and sexual harassment. The Auditor discovered the facility's leadership support its staff in the prevention, detection and response efforts.

The facility's population was educated regarding the agency's prevention, detection and response efforts towards sexual abuse and sexual harassment. Most residents interviewed informed the Auditor they were confident in staff's abilities and felt staff would maintain confidentiality with sexual abuse related information. The Auditor observed staff interactions with the resident population while on site. All interactions were professional and appeared as if staff have developed appropriate working relationships with the population. The overall population interviewed by the Auditor felt sexually safe in the facility. Each resident informed the Auditor facility staff are professional and take incidents and threats of sexual abuse or sexual harassment seriously. Formal interviews with staff revealed they are knowledgeable in the policies and procedures to prevent, detect and respond to incidents of sexual abuse and sexual harassment.

The agency ensures its investigators are trained to conduct sexual abuse and sexual harassment investigations in confinement settings. Investigators understand how to conduct appropriate investigations following an allegation of sexual abuse and sexual harassment. The facility's investigator understands the requirement to refer criminal acts of sexual abuse to the local law enforcement agency for criminal investigation. Policy requires investigations be objective and are conducted promptly and thoroughly. The Dismas Charities, Jackson facility, as well as all other Dismas Charities facilities, utilize agency procedure Sexual Abuse/Harassment/Misconduct/Prevention Intervention mandating zero tolerance relating to the sexual behavior of clients, staff, volunteers, contractor and work crew supervisors. The procedure included definitions and provided training requirements of staff. The procedure also outlines the agency and facility's approach to preventing, detecting, and responding to sexual abuse and sexual harassment. The procedure defines sexual behavior as any "Verbal and physical conduct of a sexual nature directed toward a resident by another resident, staff member, agent or volunteer of a correction agency, department or private organization. Sexual misconduct by staff against a resident is prohibited by policy. Sexual misconduct, as it relates to residents, is a sexual advance, welcome or not, by a resident, staff member, agent or volunteer. The curriculum indicated pat searches, cross-gender pat searches, searches of transgender and intersex residents are conducted in a respectful, professional manner and prohibits cross-gender strip searches as well as cross-gender visual body cavity searches of any resident. Curriculum also explains that a transgender or intersex resident should not be searched or physically examined for the sole purpose of determining the resident's genital status. Findings:

Dismas Charities Inc. Procedure, Sexual Abuse/Harassment/Misconduct/Prevention/Intervention, Investigations dated 2/10/2015, requires administrative and/or criminal investigations be completed on all incidents of resident-on-resident sexual abuse or staff sexual misconduct. Investigations are to be conducted promptly, thoroughly, and objectively for all allegations. Evidence protocol that maximizes the potential for obtaining usable physical evidence for administrative proceedings or criminal proceedings are utilized. Dismas Charities refers allegations of Sexual Abuse, Harassment and Staff misconduct to the appropriate Authority Having Jurisdiction (AHJ) over the resident concerned for investigation. The Authority Having Jurisdiction (AHJ) is dependent on the resident's status so the investigation may be conducted by the Bureau of Prisons, Department of Corrections or potentially the Jackson Police Department for those residents on parole.

Individuals assigned to investigate allegations of sexual abuse or sexual harassment are required to attend specialized training that provides the skills and knowledge necessary to investigate Sexual Abuse and Harassment allegations that are made. Investigators attend Specialized Training: Investigating Sexual Abuse in Confinement Settings that cover PREA Investigative Standards, Legal Issues and Agency Liability, Trauma and Victim Response, the Role of Medical and Mental health Practitioners in Investigations, Interviewing Techniques, First Responder and Evidence Collection, Report Writing and Prosecutorial Collaboration. Investigators are also required to complete the same PREA training courses that all staff are required to complete. Dismas Charities, Inc. investigators only conduct administrative investigations. The Jackson Police Department would conduct an investigation involving potential criminal allegations.

The facility reports that they do not house youthful residents. The facility reports in their PAQ that the evidence protocol was adapted from or otherwise based on the most recent edition of the DOJ's Office on Violence Against Women publication, "A National Protocol for Sexual Assault Medical Forensic Examinations, Adults/Adolescents," or similarly comprehensive and authoritative protocols developed after 2011.

The above policies require and the facility reports that all residents who experience sexual abuse are provided access to forensic medical examinations by a Sexual Assault Forensic Examiner (SAFE) or Sexual Assault Nurse Examiner (SANE) at no financial cost to the resident. The facility would utilize the Baptist Medical Center to conduct all forensic exams. An interview with the SANE at the Baptist Medical Center indicated they are responsible for conducting all forensic exams from Dismas Charities-Jackson. Both the facility and the SAFE/SANE reported no forensic medical exams had been conducted over the last twelve (12) months on residents from Dismas Charities-Jackson. Any evidence collected from a forensic exam is sent to the state's crime lab. Baptist Medical Center has a SANE on call after normal operating hours.

In addition, the Bureau of Prisons (BOP) Program Statement 5324.11, Sexually Abusive Behavior Intervention and Prevention Program, requires Psychology staff to establish an agreement with community service providers that are able to provide confidential emotional support services as it relates to sexual abuse. Community Treatment Services (CTS) is responsible for providing a community provider that will conduct a mental health assessment and counseling for those inmates who fall under PREA while the inmate resides in a Residential Reentry Center and/or on home confinement.

The facility has been communicating with the Mississippi Coalition Against Sexual Assault in order to establish an MOU to provide victim advocacy services for potential sexual assault victims. The Mississippi Coalition Against Sexual Assault will provide confidential emotional support to residents who are victims of sexual abuse and will accompany a resident during a forensic exam. Residents are provided information from the Mississippi Coalition Against Sexual Assault during their orientation. A telephonic interview was held with a representative from the Mississippi Coalition Against Sexual Assault. She indicated there had been no calls from residents assigned to Dismas Charities-Jackson in the last twelve (12) months. In addition, the Bureau of Prisons (BOP) Program Statement 5324.11, Sexually Abusive Behavior Intervention and Prevention Program, requires Psychology staff to establish an agreement with community service providers that are able to provide confidential emotional support services as it relates to sexual abuse. Community Treatment Services (CTS) is responsible for providing mental health assessment and counseling for those inmates who fall under PREA while the inmate resides in a Residential Reentry Center and/or on home confinement.

After reviewing agency policy and procedures, staff interviews, training records, supplemental documentation and observations made during the onsite portion of the audit, this auditor finds the facility compliant with all provisions of the standard.

Findings:

In accordance with the Dismas Charities-Jackson Operations Manual, Training, dated 11/18/2020, require that all staff be trained (at hire and annually) to recognize the signs of resident sexual victimization and understand their responsibility in the detection, prevention, prohibition, reporting, and consequences of sexual abuse/harassment. The training contains all ten required components of the standard which include: (1) The agency's zero tolerance policy for sexual abuse and sexual harassment, (2) How to prevent, detect, report and respond to allegations of sexual abuse and sexual harassment, (3) Resident's rights to be free from sexual abuse and sexual harassment, (4) The rights of residents and employees to be free from retaliation for reporting sexual abuse and sexual harassment, (5) The dynamics of sexual abuse and sexual harassment in confinement, (6) The common reactions of sexual abuse and sexual harassment victims, (7) How to detect and respond to signs of threatened and actual sexual abuse, (8) How to avoid inappropriate relationships with residents, (9) How to communicate effectively and professionally with residents, including lesbian, gay, bisexual, transgender, intersex, or gender nonconforming residents; and (10) How to comply with relevant laws related to mandatory reporting of sexual abuse to outside authorities.

Within the first week of employment with Dismas Charities Inc., all new employees are required to read and understand the PREA information presented to them and acknowledge by signing and dating the Staff Initial Orientation Checklist and the Staff/Volunteer Acknowledgement Sexual Abuse Prevention and Intervention form (dci903 form). The Staff Initial Orientation Checklist and the Staff/Volunteer Acknowledgement Sexual Abuse Prevention and Intervention form (dci903 form) were provided and are stored in each employee's personnel file in the Director's office. This auditor observed the PREA Acknowledgement Forms in all staff personnel files that were reviewed. By signing the form, staff acknowledge that they received the training and understand their responsibilities in reporting incidents of sexual abuse and sexual harassment. All employees are trained as new hires, regardless of their previous experience. Training is tailored to both genders so additional training is not necessary.

All staff receive Sexual Abuse/Harassment/Misconduct/Prevention/Intervention training upon hire and annually. Refresher training is conducted every month during staff meetings. Training records indicate staff completed the required training during the last training year. Employee training records are maintained in each employee's personnel file. Upon completion of courses staff acknowledge their completion through a signature.

After reviewing agency policy and procedures, staff interviews, and observations made during the onsite portion of the audit, this auditor finds the facility exceeds this standard.

Findings:

Dismas Charities-Jackson Operations Manual, Procedure 9.A Referral and Intake Processing, Referrals, Dismas Charities-Jackson Operations Manual, Procedure 10.Q Programs, Resources and the Dismas Charities, Inc. Screening Tool were reviewed. Staff are required to complete the PREA Screening Questionnaire with the resident upon their arrival at the facility. Upon completion/signing of this document, staff are to place it in the Director's mailbox for review and assessment of risk factors. Staff are also required to complete the Bureau of Prisons Initial Intake Form which includes evaluating the physical appearance and emotional condition of the resident. A re-assessment of the PREA screening questionnaire will be included in every counseling session and documented under "Health Assessment". This is accomplished by asking the resident if there have been any changes in their situation since the initial screening or last meeting. Case Managers ask PREA questions every week during the first month and then every two weeks after the first month.

Dismas Charities-Jackson Operations Manual, Procedure 9.A Referral and Intake Processing, Referrals requires staff to complete the Initial PREA Screening Questionnaire (dci902) and upon completion forward it to the Director for further review and evaluation. Staff conduct screening to determine a resident's risk of being sexually abused by other residents or their risk of being sexually abusive towards other residents. The screening shall utilize an objective screening instrument that obtains the following minimum criteria to assess residents for risk of sexual victimization: Whether the resident has a mental, physical, or developmental disability; The age of the resident; The physical build of the resident; Whether the resident has previously been incarcerated; Whether the resident's criminal history is exclusively nonviolent; Whether the resident has prior convictions for sex offenses against an adult or child; Whether the resident is or is perceived to be gay, lesbian, bisexual, transgender, intersex, or gender nonconforming; Whether the resident has previously experienced sexual victimization; and the resident's own perception of vulnerability; Although the screening instruments initially provided did not include the minimum criteria, the PREA Coordinator shared that he was in the process of making changes that include all of the criteria.

The initial screening considers prior acts of sexual abuse, prior convictions for violent offenses, and history of prior institutional violence or sexual abuse (as known to the agency) in assessing residents for risk of being sexually abusive. Counselors the resident's risk of victimization or abusiveness based upon any additional, relevant information received by the facility since the intake screening by asking the PREA questions every week during the first month and then every two weeks after the first month. Residents are not disciplined for refusing to answer or for not disclosing complete information related to questions regarding whether the resident has a mental, physical, or developmental disability, whether the resident is or is perceived to be gay, lesbian, bisexual, transgender, intersex, or gender non-conforming, whether the resident has previously experienced sexual victimization and the resident's own perception of vulnerability during the screening or assessment process.

The information gained from the screening for risk of victimization and abusiveness is limited to staff on a "need to know basis". The information in the report is used in determining housing and bed assignments with the goal of keeping residents who are high risk of being sexually victimized separated from those who are at high risk for being sexually abusive. The facility should make individualized determinations about how to ensure the safety of each resident.

According to the PAQ, the facility reassessed 100% of the ninety-one (91) residents who entered the facility within the past

(12) months whose length of stay in the facility was for (72) hours or more and who were screened for risk of sexual victimization or risk of abusing other inmates. The facility also reported that eighty (80) residents who entered the facility whose length of stay was for (30) days or more who were reassessed for their risk of sexual victimization or of being sexual abusive within (30) days.

After discussing updates of the screening instrument, reviewing agency policy and procedures, staff interviews, resident interviews and observations made during the onsite portion of the audit, this auditor finds the facility exceeds this standard.

As a residential community confinement facility, work, education and program assignments are not conducted in-house. The agency and facility make individualized determinations about how to ensure the safety of each resident based on data gathered from the risk assessment, information from prior medical/mental health screenings, additional records reviews, information obtained from the resident and observations made by staff. A transgender or intersex resident's own view with respect to his own safety is given serious consideration when making facility and housing placement decisions and programming assignments.</p> <p data-bbox="245 1151 1445 1245">The Dismas Charities-Jackson case managers are responsible for screening each resident that enters the facility. The Director is responsible for ensuring those on the list for high risk for abusiveness are not placed with those at high risk for victimization.</p> <p data-bbox="245 1276 1485 1469">Interviews conducted with the Dismas Charities Inc. PREA Coordinator indicated that the facility would take into consideration on a case-by-case basis whether a resident's housing and program assignment would ensure the resident's health and safety and whether the assignment would present management or security problems. While conducting the onsite tour, the auditor toured housing, bed, job assignment and program areas. Interviews confirmed that at intake, the results of the screening are used to determine housing and bed assignment. There were no transgender residents at the facility at the time of the onsite audit.</p> <p data-bbox="245 1500 1477 1626">All residents are offered the opportunity to shower separately from other residents based on the design of the bathroom/shower areas. Staff reported that no transgender residents would be assigned to a dedicated housing unit while at Dismas Charities-Jackson. Findings:

Dismas Charities Inc. Sexual Abuse/Harassment/Misconduct/Prevention/Intervention Procedure 24.3, Prevention and Reporting requires that multiple internal ways should be provided for residents to privately report sexual abuse and sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Ways of reporting incidents of sexual abuse and harassment include: Direct reporting to a staff member, completing an Action Request on the kiosk, and third-party reporting, reporting via the published (Kentucky) helpline and through a local rape crisis center. While touring the facility, signage was observed in multiple areas in each living and dayroom area. The signage included instructions and numbers that can be called to report incidents of sexual abuse/assault. Additional signage provided contact information for Resident reporting, Family & Friends Reporting, Employee Reporting and Employee Responsibilities. Third party reporting can be made via email, phone or letter. When residents arrive at the facility, they are provided a document that explains how to report incidents anonymously. The residents are also provided telephone numbers to access the Rape Crisis Hotline in Jackson, MS, the Center for Violence Prevention in Pearl, MS and the National Sexual Assault Hotline. The auditor interviewed staff from the Rape Crisis Hotline and the Center for Violence Prevention. Representatives from both places indicated that there had been no calls from residents from Dismas Charities-Jackson during the past (12) months requesting any emotional support services related to a sexual abuse or sexual harassment occurring at the facility.

When residents participate in Orientation, they are provided a pamphlet regarding PREA Awareness, to include different ways to report incidents of sexual abuse and sexual harassment. The brochure refers to a Kentucky Hotline number so it was recommended that this number be posted near the telephones and on bulletin boards. The brochure provided contains a telephone number to call as well as an explanation of the resident's rights in regard to sexual safety.

Posters that were observed throughout the facility during the tour and includes methods for staff, residents and visitors to report sexual abuse or sexual harassment.

Even though the facility does not house residents detained solely for civil immigration purposes, policy still requires that residents detained solely for civil immigration purposes shall be provided information on how to contact relevant consular officials and relevant officials at the US Department of Homeland Security.

Policy also requires that staff accept reports of sexual abuse and sexual harassment that are made verbally, in writing, anonymously or from a third party. Each employee has a duty to report any and all violations and are to immediately notify the Director or Assistant Director and document on an Extraordinary Occurrence Report. Policy also allows staff to privately report sexual abuse and sexual harassment of residents. The ways for staff to report are defined in the procedure and is

also included on the PREA posters that are prominently posted throughout all areas of the facility.

Interviews with random residents confirmed they were educated on how to report sexual abuse and sexual harassment utilizing the hotline numbers posted on each housing unit. Most residents were aware of where to go to find reporting methods in their Orientation paperwork. Interviews with random staff confirmed they were all comfortable in reporting situations to the Director and knew additional ways to report were on the posters.

After reviewing agency procedures, staff and resident interviews, interviews with external entity and observations made during the onsite portion of the audit, this auditor finds the facility meets this standard based on the multiple reporting methods provided for the resident population and staff.

Dismas Charities Jackson Operations Manual Procedure 14.C, Administrative Remedy Procedure, Allegation of Sexual Abuse allows a resident to submit a grievance regarding an allegation of sexual abuse at any time, regardless of when the incident occurred. Policy requires all grievances that are filed regarding allegations of sexual abuse or sexual harassment be submitted to the Director for appropriate action in accordance with PREA.

If a resident files a grievance alleging emergency substantial risk of imminent sexual abuse, the Director will take immediate action to safeguard to resident and provide an initial response within 48 hours and shall issue a final agency response within five days. Residents are educated and advised of the Administrative Remedy Procedure during their Orientation upon arrival. Residents are provided both written material and an oral explanation of the procedure and provided the opportunity to ask questions regarding the grievance procedure. Residents are permitted to request assistance in understanding the process and also in completing a grievance. Third parties, including other residents, staff members, family members, attorneys or outside advocate, shall be permitted to assist residents in filings requests for Administrative Remedy relating to allegation of sexual abuse, and shall be permitted to file such requests on behalf of the resident. If a third-party files such a request on behalf of a resident, Dismas requires as a condition of processing that the alleged victim agree to have the request filed on his or her behalf, and may also require the alleged victim to personally pursue any subsequent steps in the Administrative Remedy Process. If the resident declines to have the request process on his or her behalf, the resident's decision will be documented.

The facility reported that there were no grievances alleging sexual abuse filed by residents in the past twelve (12) months in which the resident declined third-party assistance, containing documentation of the resident's decision to decline.

The policy also explains that a resident can submit a grievance without submitting it to the staff member who is subject of the complaint. The policy does not allow the grievance to be referred to the staff member who is subject to the complaint.

Administrative Remedy Procedures, Filing a Grievance (Sexual), requires that once the investigation is complete, the Director will issue a final decision on the merits of any portion of the grievance alleging sexual abuse within 90 days of the initial filing of the grievance. The written findings are relayed to the resident, and what resolution, if any, will be implemented. If the resident doesn't agree with the action of the Director they may file a formal grievance with the Bureau of Prisons through established Administrative Remedy Procedures. If the Director fails to respond to the grievance within 90 days, the resident may consider the grievance denied and may utilize the Administrative Remedy Process pertaining to their legal status.

The facility reported that there had been zero (0) grievances filed in the last twelve (12) months that alleged sexual abuse that reached final decision within ninety (90) days of being filed. None of these grievances required an extension. There were zero (0) grievances filed in the last twelve (12) months that alleged sexual harassment that reached final decision within (90) days of being filed. Neither of these grievances required an extension either.

If a resident files a grievance alleging emergency substantial risk of imminent sexual abuse, the Director will take immediate action to safeguard the resident and provide an initial response in 48 hours, and shall issue a final agency decision within five (5) calendar days. The initial response and final agency decision shall document the agency's determination whether the resident is in substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance.

Interviews with random residents confirmed the multiple ways a resident could report allegations of sexual abuse or sexual harassment, submitting a grievance was one of those ways. The residents explained the grievance boxes on the housing units. None of the random residents interviewed had ever filed a grievance regarding an allegation of sexual abuse or sexual harassment. Random staff interviewed shared how a resident could give a grievance directly to the Director.

After reviewing agency policy and procedures, staff and resident interviews, and observations made during the onsite portion of the audit, this auditor finds this standard in compliance.

BOP Community Treatment Services (CTS) is responsible for providing mental health assessments and counseling for those residents who fall under PREA while the resident resides in the Residential Reentry Center and/or on home confinement.</p> <p>Residents have access to community providers based on their status while assigned to the facility. Mailing addresses and telephone numbers, including toll-free hotline numbers for local, state, or national victim advocacy or rape crisis organizations are provided to residents during their intake and Orientation. Enabling reasonable communication between residents and the organizations/agencies in as confidential manner as possible is also required per policy.</p> <p>The facility recently reached out to the Mississippi Coalition Against Sexual Assault in Jackson. The Mississippi Coalition Against Sexual Assault will provide free, confidential sexual abuse advocacy services for the Dismas Charities-Jackson resident population. The Mississippi Coalition Against Sexual Assault crisis line telephone number is available to the residents. The auditor conducted a telephone interview with a representative from the Mississippi Coalition Against Sexual Assault and she indicated that the Mississippi Coalition Against Sexual Assault had not received any telephone calls in the past twelve (12) months from residents at Dismas Charities-Jackson.</p> <p>Interviews with random staff and the PCM indicated the residents are provided with a PREA brochure and orientation material that contained facility guidelines regarding PREA, information on how to report incidents of sexual abuse and sexual harassment, including telephone numbers of outside agencies. Findings:

Dismas Charities Inc. Sexual Abuse/Harassment/Misconduct/Prevention/Intervention Procedure 24.3, Prevention and Reporting requires all residents/staff to report when a resident has been victimized or the resident has knowledge of sexual abuse within the center. Every staff member has the responsibility to immediately address any observed behavior or conversations involving a resident or co-worker that suggests inappropriate communications and/or contact.

When a staff member observes two or more residents engaged in communication and/or behaviors that suggest an inappropriate relationship may be forming, they are to talk to the involved residents. Residents are to be counseled on the rules prohibiting relationships and sexual contact. Residents are to be reminded of the sexual /abuse policy. If residents are sitting too close to one another or have engaged in any kind of physical contact, regardless of how small, they are to be separated and warned the first time with repeat occurrences receiving disciplinary write ups. The incident is to be documented in the House Log. Residents who are found to be together in an unauthorized area are to receive a disciplinary write up.

When a staff member observes a co-worker/volunteer/contractor or one or more residents engaged in communication and/or behaviors that suggest an inappropriate relationship might be forming, the staff member is to immediately report the matter to the Director, who will follow protocols for gathering information and making notifications. The Director will in all cases notify the RVP within thirty (30) minutes of being made aware of an incident or a possible issue.

Dismas Charities Inc. Sexual Abuse/Harassment/Misconduct/Prevention/Intervention Procedure .6, Protection Against Retaliation requires that all residents and staff who report sexual abuse or sexual harassment or cooperate with sexual abuse or sexual harassment investigations are protected from retaliation by other residents or staff. It is required that all staff report immediately and according to agency policy any retaliation against residents or staff who reported such an incident or may have contributed to or failed to prevent such an incident. The director or designee is responsible for monitoring against retaliation. Multiple protection measures, such as dorm/room changes or transfers for resident victims or abusers, removal of alleged staff or resident abusers from contact with victims, and emotional support services for residents or staff who fear retaliation for reporting sexual abuse or sexual harassment or for cooperating with investigations may be used. For at least 90 days following a report of sexual abuse, the center monitors the conduct and treatment of residents or staff who reported the sexual abuse and of residents who were reported to have suffered sexual abuse to see if there are changes that may suggest possible retaliation by residents or staff, and shall act promptly to remedy any such retaliation. Items monitored include any resident disciplinary reports, housing, or program changes, or negative performance reviews or changes in staff schedules or hours. The monitoring shall continue beyond 90 days if the initial monitoring indicates a continuing need.

In the case of residents, such monitoring shall also include checks when meeting with counselor during scheduled times. If any other individual who cooperates with an investigation expresses a fear of retaliation, the center shall take appropriate measures to protect that individual against retaliation. The monitoring will end if the allegation is unfounded or the resident is transferred or released.

Staff may receive an anonymous note, hear a rumor, or other third-party information (including from a resident's family or friend) that a resident has been the victim of sexual abuse. Staff must immediately report all information to the Director and follow-up with completion of an Extraordinary Occurrence Report (dci422).

By law, the identity of an alleged victim of sexual abuse is confidential information. The sharing of sensitive information is limited to those staff who must know in accordance with policy, federal and state statute and ethical standards. Staff must, to the extent possible, limit the release of information in an effort to protect the victim and reporter of sexual abuse from retribution. The facility would never have a resident under the age of 18 but may have a resident that is considered a vulnerable adult. Dismas will also notify the appropriate supervising authorities of the reporting resident.

Random staff interviews, indicated staff understood their responsibility to report any knowledge, suspicion or information of sexual abuse or sexual harassment. Staff also understood that any information related to sexual abuse or sexual harassment is to be confidential and not be shared with anyone other than those that need to know. Staff said they would report to the Director. Through an interview with the Director, she advised that any reports of allegation of sexual abuse or sexual harassment that are reported through a third-party would be referred to the Regional Vice-President and would be processed as any other allegation.

At the time of the initial report of sexual abuse while at another facility, the center staff receiving the report will notify the director immediately. The Director will document and notify the supervising authorities and the management of the facility involved within 72 hours of the resident reporting the incident to staff. Staff will offer counseling services to the resident and medical services if needed. Dismas Charities Inc. Sexual Abuse/Harassment/Misconduct/Prevention/Intervention Procedure .4, Response Procedures requires first responders to ensure that the alleged resident victim is separated from the alleged resident perpetrator. The main objective is to coordinate actions taken in response to an incident of sexual abuse, among staff on duty, medical and mental health practitioners, investigators, and center management. The goal is to safeguard the resident from further physical or psychological harm.

First Responders/staff on duty or receiving an alleged report of sexual abuse/harassment are required to separate the alleged perpetrator and victim so that neither can hear nor see the other. The 1st Responders/Staff are then encouraged to alert other staff for assistance and inform the Director of the alleged sexual abuse and remain with the alleged victim to provide safety and support and if needed, to ensure that the victim does not wash, shower, change clothes or otherwise compromise physical evidence on his/her body prior to examination. If needed, ensure all parties involved received emergency medical treatment and arrange for a Sexual Assault Forensic Exam (SAFE) if wanted. If resident is unclear about the need for an exam, the Sexual Assault Nurse Examiner (SANE) should make that decision. If needed and directed, contact the State police. If needed and directed, secure the crime scene, take photographs as needed, and get names of witnesses, if any. Staff are also required to start a log of events and complete an Extraordinary Occurrence Report. The Director will ensure that all of the previously listed steps were completed as well as notifying the Authority having Jurisdiction (AHJ) and the Regional Vice President and ensure on-going support for the victim. If the resident believes they are no longer safe in their current environment, arrangements are made with the Bureau of Prisons, US Probation/Pre-Trial or the KY Department of Corrections as appropriate to have the resident moved to another location, including an administrative transfer back to an institution. The Director will ensure to start or assist and support any investigation by the State police or Local Law Enforcement and coordinate with a Rape Crisis Advocate for continued mental health treatment and counseling as needed. The Director also ensures that all actions and information are documented.

Interviews were conducted with random staff/First Responders and all staff were able to recite First Responder responsibilities in accordance with agency procedure when it is learned a resident was sexually abused. A laminated credit-card style information card that detailed First Responder duties when they learn a resident was sexually abused. The card had contact information for those who are to be contacted if a situation is reported. Staff all reported they attended the required training upon being hired and then attended training each year after they were hired. Training records were reviewed and indicated that staff attended the required training and learned of the proper responses when learning a resident was sexually abused.

The Director/PCM reported that there had been no incidents reported to security and non-security staff members that a resident had been sexually abused in the past twelve (12) months.

Dismas Charities Inc. Sexual Abuse/Harassment/Misconduct/Prevention/Intervention, Procedure 24.5, Investigations requires the facility conduct a systematic and official inquiry into all allegations of sexual abuse/harassment reported or discovered to aid in determining the facts from all available evidence, prevent further trauma to the victim, safeguard the community, protect the rights of all parties and hold accountable those parties responsible for violating the law. An effort should be made for a "multi-disciplinary team" approach which may include Investigators, victim advocate, social services, mental health, district attorney, etc.

Sexual abuse and sexual harassment administrative investigations shall be conducted by staff that have received special training in sexual abuse/harassment investigations or for criminal investigations, the appropriate authority having jurisdiction. Interviews with a Dismas Charities Inc. investigator confirmed their completion of the Specialized Training: Investigating Sexual Abuse in Confinement Settings. Dismas Charities Inc. currently has nine (9) staff who has attended the Investigator training. When an outside agency investigates sexual abuse, the facility shall cooperate with outside investigators and shall endeavor to remain informed about the progress of the investigation. The Director notifies the Regional VP and the PREA Coordinator of all allegations of sexual abuse and harassment who will ensure completion of an administrative investigation. One of the nine (9) trained PREA investigators could be assigned to conduct the administrative investigation.

Investigators shall gather and preserve direct and circumstantial evidence, including any available physical and DNA evidence and any available electronic monitoring data including video and/or audio recordings; shall interview alleged victims, suspected perpetrators, and witnesses. The investigator shall impose no standard higher than a preponderance of the evidence in determining whether allegations of sexual abuse or sexual harassment are substantiated.

The Investigators are trained to review prior complaints and reports of sexual abuse involving the suspected perpetrator when determining credibility of the allegations. When the quality of evidence appears to support criminal prosecution, appropriate referrals will be made. The credibility of an alleged victim, suspect, or witness shall be assessed on an individual basis and shall not be determined by the person's status as resident or staff. During the interviews with the Investigators, they determine the credibility of the subject of an interview depending on their ability to provide verifiable details that contribute to the veracity of their story. The more verifiable details they provide, the more it contributes to the veracity of their story. The Investigator's questions also address things that only appear to be secondary to the line of questioning, but are key to establishing the credibility of their narrative. The Investigators explained they like to measure whether the subject's non-verbal indicators of truthfulness align with their verbal indicators that they are being truthful.

The policies also require that investigations include an effort to determine whether staff actions or failures to act contributed to the abuse. Administrative Investigations shall be documented in written reports that include a description of the physical and testimonial evidence, the reasoning behind credibility assessments, and investigative facts and findings. Criminal Investigations shall be documented in a written report that contains a thorough description of physical, testimonial, and documentary evidence with all documentary evidence attached where feasible. Substantiated allegations of conduct that appears criminal shall be referred for prosecution.

According to the PAQ, and verification from interviews with the Director/PCM, it was confirmed that there were no allegations of conduct that appeared to be criminal that was referred for prosecution since the last PREA audit. There were no allegations of sexual abuse or sexual harassment at all at the facility over the past 12 months.

All written investigation reports will be retained as long as the alleged abuser is incarcerated or employed by the agency, plus five (5) years. The departure of the alleged abuser or victim from the employment or control of the facility or agency shall not provide a basis for terminating an investigation.
